

AN ORDINANCE ESTABLISHING CHARGES AND RATES FOR THE USE AND SERVICES OF THE WATERWORKS SYSTEM OF LAKESIDE WATER DISTRICT.

WHEREAS, the Lakeside Water District, Jackson County, Illinois, by proper proceedings, has authorized the construction of a waterworks system through the issuance of Waterworks Revenue Bonds of said District, in the amount of One Hundred Sixty Thousand Dollars, (\$160,000); and

WHEREAS, it is necessary that the District establish rates and charges for the services of said waterworks sufficient to provide at all times funds adequate to pay the cost of operation and maintenance of the waterworks system, to provide an adequate depreciation fund and to pay the principal of and the interest on the Revenue Bonds issued for the payment of the cost thereof;

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE LAKESIDE WATER DISTRICT, JACKSON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. That there shall be and there are hereby established rates and charges for the use of and for the water supplied by the waterworks system of the Lakeside Water District, Jackson County, Illinois, as follows:

SERVICE CHARGE. All customers shall pay a Service Charge of Five Dollars (\$5.00) per month.

WATER CHARGE. In addition to the Service Charge, all customers shall pay for water consumed, as shown by the water meters, the following charges:

First	10,000 gallons per month	.....	65¢ per thousand
Next	90,000 gallons per month	.....	50¢ per thousand
Next	100,000 gallons per month	.....	40¢ per thousand
Over	200,000 gallons per month	.....	30¢ per thousand

MINIMUM CHARGE. The minimum monthly bill for all customers, including the service charge and the water charge shall be Six Dollars and Ninety-Five Cents (\$6.95).

PENALTY. A penalty of 10% shall be added to each account if not paid by the 10th of the month in which the bill is presented. Failure to receive the bill shall not relieve the customer of said penalty.

SECTION 2. That said rates and charges for service shall be payable on a monthly basis. The owner of the premises, the occupant thereof, and the user of the services shall be jointly and severally liable to pay for the service on such premises, and the service is furnished to the premises by the Lakeside Water District only, upon the condition that said owner, occupant and user shall be jointly and severally liable therefor to the District.

SECTION 3. That if the rates and charges for such services are not paid within thirty (30) days after rendition of the bill for such services, such services shall be discontinued without further notice.

SECTION 4. That the Treasurer shall receive all revenues from the waterworks system and all other funds and monies incident to the operation of such system as the same may be delivered to him, and deposit the same in a separate fund designated the "WATER FUND" of the Lakeside Water District, and shall be administered in conformity with the provisions of Section 11 of Ordinance No. 1 which authorized the issuance of revenue bonds of the District for the purpose of paying the cost of the construction of its waterworks system.

SECTION 5. That the Treasurer shall establish a proper system of accounts and shall keep proper books, records and accounts in which complete and correct entries shall be made of all transactions relative to the waterworks system, and at regular annual intervals, he shall cause an audit thereof to be made, and he shall render regular monthly statements thereof; such records and accounts shall be kept in accordance with the provisions of Section 15 of said Ordinance No. 1.

SECTION 6. That no water supplied by the waterworks system of the District shall be resold by any user, and such resale shall be grounds for the discontinuance of water service to the user so reselling water.

SECTION 7. That the rates and charges herein established shall be effective upon the availability of the service to the customer.

SECTION 8. That duplicates of this Ordinance shall be posted in not less than ten (10) public places in the District within thirty (30) days of its passage, no newspaper being published in the District, and shall be in effect ten (10) days after its posting.
