

ORDINANCE NO. 3

AN ORDINANCE TO AMEND ORDINANCE NO. 2, BEING AN ORDINANCE ESTABLISHING CHARGES AND RATES FOR THE USE AND SERVICE OF THE WATERWORKS SYSTEM OF LAKESIDE WATER DISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS, AND AMENDMENTS THERETO.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE LAKESIDE WATER DISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS, AS FOLLOWS:

SECTION 1. That Section 1 of Ordinance No. 2 be amended to read as follows:

That there shall be and there are hereby established rates and charges for the use of and for the water supplied by the waterworks system of the Lakeside Water District, Jackson and Williamson Counties, Illinois, as follows:

SERVICE CHARGE: All customers shall pay a basic service charge of \$5.00 per month. All customers operating an apartment building or apartment buildings on the premises to which water is supplied shall pay an additional service charge of \$1.00 per month per apartment. All customers operating a trailer court on the premises to which water is supplied shall pay an additional service charge of \$1.00 per month per trailer. All customers operating a dormitory or dormitories on the premises to which water is supplied shall pay an additional service charge of \$1.00 per month for each four persons, or fractional part thereof, occupying said dormitory or dormitories.

WATER CHARGE: In addition to the Service Charge, all customers shall pay for water consumed, as shown by the water meters, the following charges:

First 10,000 gallons per month..... 65 cents per thousand  
Over 10,000 gallons per month..... 55 cents per thousand

MINIMUM CHARGE: The minimum monthly bill for all customers, including the basic Service Charge and the Water Charge, shall be \$6.95. The minimum charge includes 3000 gallons of water.

PENALTY: A penalty of 10% of the total bill shall be added to each account if not paid by the 10th of the month in which the bill is presented. Failure to receive the bill shall not relieve the customer of said penalty.

SECTION 2. That except as hereby modified and changed, Ordinance No. 2 shall remain the same and in full force and effect.

SECTION 3. That the rates and charges herein established shall be effective as of June 1, 1966..

SECTION 4. That copies of this Ordinance shall be posted in not less than ten public places in the District within 30 days of its passage, no newspaper being published in the District, and shall be in effect ten days after its posting.
