

ORDINANCE NO. 41

TAP FEE CHARGE/LAVERN ROAD EXTENSION

WHEREAS, Lakeside Water District, located in Jackson and Williamson Counties, Illinois, is a duly organized water district pursuant to the statutes of the State of Illinois, and is authorized to enact ordinances, and,

WHEREAS, Lakeside Water District awarded a contract to build a water main extension with a four-inch line on Lavern Road on the 11th day of December, 2002, and,

WHEREAS, on the 8th day of February, 2003, a substantial portion of the property located along the proposed water line was sold at auction to various land developers, and,

WHEREAS, the Board of Trustees determined that it would be advisable to increase the size of the water main from four-inch to six-inch at its Board meeting on the 17th day of March, 2003, and,

WHEREAS, the increase in water line size cost the District an additional \$19,613.75, and,

WHEREAS, it was determined by the Board of Trustees at its meeting held on the 17th day of March, 2003 that any person or entity tapping onto the six-inch main along Lavern Road or the four-inch main located on Strawberry Lane, with a line other than a standard residential line, shall pay to the Water District the sum of \$6,500.00 as a tap fee.

NOW THEREFORE, BE IT ENACTED AND ORDAINED BY THE BOARD OF TRUSTEES OF THE LAKESIDE WATER DISTRICT, THE FOLLOWING ORDINANCE CONCERNING THIS MATTER.

“Tap Fee Charge/Lavern Road Extension”

SECTION 1: Any person or entity tapping onto the six-inch main along Lavern Road/Sycamore Road or the four-inch main along Strawberry Lane or the four-inch main along Haney Road, shall pay to the Water District the sum of \$6,500.00 representing a tap fee. This tap fee is in addition to any permit fees or requirements of the Illinois Environmental Protection Agency and any other applicable governmental entities. The effective date of this Ordinance shall be the date of its enactment by the Lakeside Water District Board.
