

ORDINANCE NO. 52

AN ORDINANCE TO AMEND ORDINANCE NO. 2 AS AMENDED, BEING AN ORDINANCE ESTABLISHING RULES, REGULATIONS AND RATES AND CHARGES FOR THE USE AND SERVICE OF THE WATERWORKS SYSTEM OF THE LAKESIDE WATER DISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS.


BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE LAKESIDE WATER DISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS, AS FOLLOWS:

Section 1: That Section 1 of Ordinance No. 2 as amended, be amended to read as follows:

Service Charge: All customers shall pay a basic service charge of \$8.00 per month. All customers operating an apartment building or buildings or hotel or motel or dormitories on the premises to which water is supplied shall pay an additional service charge of \$1.00 per month per apartment or hotel/motel room. All customers operating a trailer court on the premises to which water is supplied shall pay an additional service charge of \$1.00 per month per trailer.

Section 2: That except as hereby modified and changed, Ordinance No. 2, as amended, shall remain the same and in full force and effect.

ORDINANCE NO. 52

AN ORDINANCE FOR COLLECTION OF FEES AND CHARGES FOR EASEMENT PREPARATION AND AGREEMENT OF CONVEYANCE PREPARATION FROM CUSTOMERS OF THE LAKESIDE WATER DISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS.

WHEREAS, the LAKESIDE WATER DISTRICT Board of Trustees has determined that certain costs and expenses should be paid by certain customers of the District, and

WHEREAS, LAKESIDE WATER DISTRICT has a retainer agreement for its legal services, and

WHEREAS, a portion of said retainer is for preparation of easements and agreements of conveyance, and

WHEREAS, the Board of Trustees of LAKESIDE WATER DISTRICT has determined that a fee should be assessed to any customer requiring the preparation of an easement and/or an agreement of conveyance for a new service tap or new main extension.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE LAKESIDE WATER DISTRICT HEREBY ADOPTS THE FOLLOWING ORDINANCE:

SECTION 1: Any customer requiring the preparation of an easement for a service connection or any customer requiring the preparation of an easement and/or agreement of conveyance for a water main extension shall reimburse LAKESIDE WATER DISTRICT for the cost of the preparation of said easement and/or agreement of conveyance.

SECTION 2: Said customer shall reimburse LAKESIDE WATER DISTRICT on the following basis to-wit:

Easement Preparation for Service Connection	\$ <u>75.00</u>
Easement Preparation for Main Extension	\$ <u>150.00</u>
Agreement of Conveyance for Main Extension	\$ <u>150.00</u>


PUBLIC NOTICE
