

AMENDED ORDINANCE NO. 80

AN ORDINANCE TO AMEND ORDINANCE NO. 2 AS AMENDED, BEING AN ORDINANCE ESTABLISHING RULES, REGULATIONS AND RATES AND CHARGES FOR THE USE AND SERVICE OF THE WATERWORKS SYSTEM OF THE LAKESIDE WATERDISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE LAKESIDE WATER DISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS, AS FOLLOWS:

Section 1: That Section 1 of Ordinance No. 2 as amended, be amended to read as follows:

That there shall be and there are hereby established rates and charges for the use of and for the water supplied by the waterworks system of the Lakeside Water District, Jackson and Williamson Counties, Illinois, as follows:

Service Charge: There will be three rates for all customers as follows:

Service Rate 1: A rate of \$18.38 for customers with a standard flow meter (5/8 inch meter)

Service Rate 2: A rate of \$32.10 for customers with a high flow meter at a single-family residence (1 inch meter)

Service Rate 3: A rate of \$45.12 for customers with a high flow meter (1 inch or larger meter)

Equipment Surcharge: There will be 5 equipment surcharges rates for high flow meters:

Equipment Surcharge 1: A \$15.00 charge for a 1.5 inch meter;

Equipment Surcharge 2: A \$30.00 charge for a 2 inch meter;

Equipment Surcharge 3: A \$45.00 charge for a 3 inch meter;

Equipment Surcharge 4: A \$60.00 charge for a 4 inch meter;

Equipment Surcharge 5: A \$90.00 charge for a 6 inch or larger meter.

Water Charge: In addition to the service charge and equipment surcharges, all customers shall pay for water usage, as shown by the following water rates:

Water Rate 1: All water customers with a standard flow meter shall be at the rate of \$6.38 per thousand gallons.

Water Rate 2: All customers having a high flow meter shall pay a surcharge of 10% on their water usage for an effective rate of \$7.02.

Minimum Charge: The monthly bill for all customers including the Service Charge, Equipment Surcharge and the Water Charge shall be as defined in the following schedule. The minimum monthly water charge includes 2,000 gallons of water.

Minimum monthly rate schedule:



Penalty: A penalty of \$10 or 10% of the total bill, whichever is greater, shall be added to each account if not paid by the 15th of the month in which the bill is presented. Failure to receive the bill shall not relieve the customer of said penalty.

Section 2: That except as hereby modified and changed, Ordinance No. 2, as amended, shall remain the same and in full force and effect.

Section 3: That within 30 days after its adoption, this Ordinance shall be published in the Carbondale Times, a newspaper published in Jackson County, Illinois and of general circulation within the District, and shall become effective with the November 2024 billing.
